Reference Election Schedule issued vide IAP's Election Circular No. C-7 dated 8th July, 2020, enclosed herewith "Final List of Voters" for members' information.

The members may please note that the following mandatory SOPs have been advised by the Election Commission for IAP Election 2020.

The voters shall be required to do the following while entering into the polling stations at Karachi and Lahore offices:

- Wear face mask and use disposable hand gloves
- Use hand sanitizers

Avoid hand shake with the polling staff and other members

Further note that:

- Arrangements for screening of voters' body temperature (through infrared thermometer) will be made at the polling stations
- To maintain social distancing maximum **two voters/members representatives** at one time will be allowed to enter into the polling stations to cast votes, in case if more members report at the same time they will be requested to wait in the designated waiting area

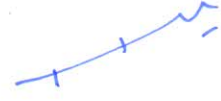
